**BILL 68 - CODES OF CONDUCT AND INTEGRITY COMMISSIONERS** 

Bill 68, the *Modernizing Ontario's Municipal Legislation Act, 2017* was adopted by the Ontario Legislature and received Royal Assent on May 30, 2017. It provided approximately 43 pages of amendments to the *Municipal Act, 2001*, the *Municipal Conflict of Interest Act* (the "MCIA"), the *Municipal Elections Act, 1996* (the "MEA"), as well as other pieces of municipal legislation.

A few of the provisions of Bill 68 came into force immediately upon receiving Royal Assent, some came into force on January 1, 2018. However, most others, specifically those having the greatest impact and requiring significant time and resources for implementation, will not come into effect until <u>March 1</u>, 2019.

Council for the Municipality of West Nipissing has already undertaken some changes, including amendments to the procedural by-law, in order to be compliant with portions of the legislation which are already in force and effect. There remains, however, much work to be done in order to be compliant with the other changes within Bill 68 that will be required as of March 1, 2019, specifically relating to the now mandatory Code of Conduct for Council as well as members of local boards, and procedures and protocols with respect to the mandatory requirement for an Integrity Commissioner and that person's expanded role and the new conflict-of-interest framework.

One of the reasons for having the more complex provisions of Bill 68 come into force in March, 2019, was to ensure that newly elected councillors who will be governed by and held accountable to the new legislation, are given an opportunity to be fully informed on their obligations and to be part of the decision making processes.

## Bill 68 Provisions in Effect as of March 1, 2019

While there are many changes in the new legislation which will take effect on March 1, 2019, the two most notable and requiring immediate action on the part of Council and Staff are mandatory codes of conduct for Council and Local Boards and the appointment of an Integrity Commissioner.

#### Mandatory Codes of Conduct for Council and Local Boards:

Bill 68 requires that municipalities establish codes of conduct for Members of Council <u>as well as for members of local boards</u>. Certain local boards will be excluded from the definition of local board for the purposes of this requirement, including a board of health, a police services board, a library board and municipal corporations. While the definition of "local board" is somewhat vague, the general understanding of what constitutes a local board is a body over which Council has control and could dissolve and assume its responsibilities. The following is a <u>preliminary</u> list of boards and committees to which the new requirements will apply:

- Committee of Adjustment
- Planning Advisory
- Agriculture Advisory
- Economic Development Committee
- Environmental Services
- Property Standards

- Museum
- Court of Revision
- Accessibility Advisory
- Heritage
- Accessibility Advisory
- Cemetery

Attached to this memo is a copy of the previously adopted Code of Conduct which has been updated to include some newly required regulations relating to the use of municipal property. Also included are some additional definitions, a new section on Conflict of Interest and expanded duties of the Integrity Commissioner, as outlined below.

It is the Mayor's wish to adopt a Code of Conduct immediately with the understanding that the document will be further amended and refined once an Integrity Commissioner has been appointed as that person will most likely be able to offer valuable input on subject matters which may not have been contemplated herein. Council will also have to determine whether the Code of Conduct, as adopted, will be amended to include all boards and committees or if a separate code of conduct policy will be adopted for boards and committees,

#### **Integrity Commissioner and their Expanded Duties:**

Municipalities must appoint an Integrity Commissioner or provide for the services of an Integrity Commissioner of another municipality.

Integrity Commissioners are now mandated to:

- oversee the application of Codes of Conduct (for both local boards and council) and the Municipal Conflict of Interest Act (the "MCIA");
- to respond to requests from Members of Council and of local boards for advice respecting their obligations under their respective code of conduct and the MCIA, and

• to provide educational information to Members of Council, members of local boards, the municipality and the public regarding the municipality's codes of conduct and the MCIA.

Specifically, Bill 68 requires Integrity Commissioners to play a critical role with respect to the MCIA. It gives new authority to the Integrity Commissioner with respect to the application of the MCIA as it relates to Members of Council and members of local boards. It establishes a new process for MCIA complaints whereby the Integrity Commissioner will be responsible for accepting complaints, conducting inquiries into alleged contraventions and making an application to a judge as appropriate.

Staff are currently undertaking research and working with other municipalities to determine the cost efficient means of obtaining the required services of an Integrity Commissioner. Discussions have been undertaken with the neighbouring municipalities as well as with Independent contractors. It is intended to obtain the services of a qualified individual who will not require an ongoing retainer fee, but whose services can be accessed on an "as-needed" basis. A full report with options is expected to be available for the first meeting in January, 2019.

#### BY-LAW 2018/92

## BEING A BY-LAW TO ACCEPT, ASSUME AND DEDICATE LANDS FOR PUBLIC HIGHWAY PURPOSES – STEWART ROAD, SPRINGER TWP.

**WHEREAS** Section 31 (2) of the *Municipal Act 2001, S.O. 2001, c.25*, as amended, requires a municipality by by-law to establish a highway for public use.

**AND WHEREAS** Section 44 does not apply to the highways until the municipality has passed the by-law;

**AND WHEREAS** it is deemed prudent to accept and assume the lands described herewith and to dedicate the same for highway purposes;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF WEST NIPISSING ENACTS AS FOLLOWS:

1. That part of the lands described in Transfers of Land to the Corporation of the Municipality of West Nipissing as listed below, be accepted and the said lands be assumed and dedicated as part(s) of the public highway(s).

Part of Lot 11, Concession 3, Part 2, Plan 36R-14250 Geographic Township of Springer Municipality of West Nipissing District of Nipissing

Being parts of the travelled road known as chemin Stewart Road, Sturgeon Falls, Ontario.
