C-1 <u>Downtown Beautification Committee</u> (Presenter: Dan Roveda and Gayle Primeau)

Mr. Roveda made a presentation to Council to inform members of the downtown beautification project. Gayle Primeau summarized the activities of the committee over the past year and thanked all participants including local businesses and municipal staff. The committee requested financial assistance from the municipality in the magnitude of \$2,500 - \$5,000 in order to enhance their activities including purchase of flowers, pesticides and other supplies for the project. Council agreed to consider the request in conjunction with the upcoming budget discussions.

D-2(a) Discussion re Proposed Amendments to the Procedural By-Law

The Municipal Clerk summarized recently legislated changes to the Procedural By-Law as well as changes made as a result of recent motions tabled. In addition, some suggested additions were discussed in relation to the reconsideration sections of the by-law. Council agreed to the legislated changes; Council did not believe that there was any need for a Consent Agenda. A discussion was held concerning the use of electronic devices in Council meetings. The Mayor suggested that a definition of electronic devices be included as well as language which would indicate that such devices be used for the purpose of accessing information for the purpose of doing council business at the table. Council also suggested that the Agenda format move Notice of Motion to after unfinished business. The mayor requested that the inaugural meeting include no council business. The mayor requested that staff research how other municipalities deal with petitions and in particular, how it can be dealt with concerning matters which have already been dealt with by Council. The mayor also suggested language be included to recognize that council are shareholders of municipally controlled corporations.

D-2(b) OPP Update

The CAO provided a verbal update to the ongoing matters with respect to the transitioning to OPP for local policing including the selection of a permanent site, a temporary site and the process for commencing the disbandment process. The CAO clarified the process for the human resources selection which is concurrent with the disbandment process. The CAO also indicated that he has been monitoring the situation in Midland and has been in communication with the local police as to his findings.

D-2(c) Discussion Regarding OPP Petition

Council discussed the petition received on January of concerning the rescindment of the by-law accepting the OPP costing proposal and requesting that council consider putting a question on the ballot for the upcoming municipal election. Councillor Roberge reminded Councillor Duhaime of his prior declaration of pecuniary interest. The Mayor indicated that she will be bringing 2 Notices of Motion; Councillor Tessier raised a point of order that the Mayor is in violation of the Procedural By-Law in that she did not support her council by signing the petition. The Chair ruled on the point of order and agreed that the Mayor was in violation of the By-Law.

D-2(d) Request for Exemption from Section 5.2 of By-Law 2015/62 (overnight winter parking)

Council considered a request from a local taxi business to be exempted from the overnight parking provisions of the Traffic and Parking By-Law. Recent by-law enforcement has brought to light that there is no exemption to the overnight parking provisions regardless of the type of business. Council was agreeable to amending the by-law to reflect that the taxi company be exempted from the overnight parking provisions.

D-3(a) Discussion re: Building Permit Fees

Council was provided with a memo concerning the amendment of building fees to reflect the allocation of fees for similarly sized buildings. Currently, the fees are based on project value and the CBO is recommending that the fees be based on gross floor area which will make the process fair for both the community and the municipality. The mayor requested that the matter be further investigated in order to ensure that the municipality does not disadvantage itself by increasing the building fees. It was agreed that the fees be further reviewed at budget discussions on February 10th.

The services is experiencing challenges both with regard to staffing and to location. The Director also indicated that the Tourism Centre is not being utilized other than as a place to use the washroom and he recommended that the centre not be staffed on a full-time basis by dedicated staff. Council raised concern at discontinuing the day camp service which is so highly utilized; however there was acknowledgment that the liability in providing such a service is increasing. The Director agreed to explore options and bring a report back to Council for options to replace the daycamp program which do not involve the level of liability that a day camp does.
