#### E-1) General Government / Gouvernement général

E-1 (a) Discussion re: Bill 68 – Modernization of the Municipal Act.

The Clerk presented a comprehensive report for Council outlining the legislated amendments that are required to the Procedural By-Law before 2018. The clerk also outlined other legislated amendments that only become effective starting in 2019. A draft Procedural By-Law incorporating all the required changes was also attached for Council's reference. It was suggested that the matter of a Code of Conduct for Council be revisited in the New Year.

#### E-1 (b) Discussion re: Procedural By-Law re: Notice of Motion Amendments

The Clerk indicated that the proposed changes in the Notice of Motion tabled by Councillor Tessier have been incorporated in the draft Procedural By-Law. Following discussion, Council agreed to the proposed changes, as written. Other suggestions to the procedural by-law were made including implementation of a section of the procedure bylaw which will keep unfinished business in front of Council, some language which addresses the use of electronic devices and social media during meeting, how agendas are

distributed (paper or electronic). Staff agreed to bring a draft back to Council in January for further discussion.

#### E-1 (c) <u>Discussion re: Proposed ground mount solar project at Hwy 17 and Landfill Site Rd. in</u> Sturgeon Falls.

The Clerk shared a correspondence received from STANTEC Consulting Ltd. regarding the development of a proposed ground mount solar project near Hwy. 17 and Landfill Site Road in Sturgeon Falls. Council has the opportunity to provide comments or ask questions regarding the project. Following discussion, Council had no concerns.

#### E-1 (d) Discussion re: Part-Time By-Law Enforcement Officer

The Director of Corporate Services / Treasurer informed Council that the position of By-Law Enforcement Officer was advertised and 1 application was received. After having undergone a successful interview process, staff is recommending that Mr. Robert Pilon be appointed as the new By-Law Enforcement Officer for the Municipality of West Nipissing.

#### E-3 (a) FARM 911 Initiative - Awareness Campaign

She further shared the "FARM 911 Initiative" whereby farmers' field entrances would also be identified with 911 numbers as to provide ease of location in the event of an emergency. The Clerk shared correspondence received from D.M. Wills Associates Ltd., on behalf of MTO, seeking authorization for the temporary closure of Hwy. 539A and/or Hwy. 539 in order to complete rapid culvert replacement. Following discussion, Council was agreeable to granting the temporary closure. It was further requested that Council be kept informed of the specific details surrounding the timing of the scheduled culvert replacement as the date approaches.

#### D-2 (a) 2018 Budget Deliberations: Date recommendations

The CAO provided a memo to Council suggesting that the full-day budget deliberation session be held on Saturday, February 10<sup>th</sup> starting at 8:30 AM. Following discussion, Council agreed to inform the

Clerk of their availability. In addition, it was recommended that arrangements be made to televise the deliberations.

#### D-2 (b) OPP Update

The CAO informed Council that a meeting was held with the OPP in late November to discuss certain transitional issues. At a worst case scenario, the transition would take place upon the construction of the new building; however it was not ruled out that they may assume responsibility earlier if suitable temporary facilities could be found. In addition, the CAO advised that there is some indication from the Province which may result in an amendment to the proposed facility costs in a favourable direction. Once a firm decision with respect to the timing of the transition is made, then the hearings can be held with the Ontario Civilian Police Commission (OCPC) to disband the existing force while at the same time undertaking rank determination processes for the assumption of the existing sworn officers. Councillor Duhaime requested that, in the future, written material be provided for consideration prior to the meeting. The CAO agreed to provide further written information concerning the OCPC hearing process.

#### D-2 (c) Discussion re: Procedure regarding Agenda(s)

The CAO provided Council with the new guidelines pertaining to the preparation of the Council agenda. These new guidelines seek to expedite the preparation time of the agenda whereby all subjects are to be submitted to the Clerk's office by end of business day on Wednesday with any supporting documentation to follow by end of business day on Thursday. Council was in agreement with the CAO's recommendation and it was also suggested that the recommendations be entrenched in policy.

**D-2 (d)** (i) A resolution to authorize the reconsideration of the Code of Conduct for Council was defeated. (refer to Addendum section)

#### (ii) Discussion re: Code of Conduct

The matter was not discussed based on the preceding resolution.

#### D-2 (e) Discussion re: Request for rental support – Filles d'Isabelle

Council was provided with a request letter from les Filles d'Isabelle seeking assistance with their rent in the amount of \$300.00 per month. Following discussion, Council was agreeable to renewing the existing commitment.

#### D-2 (f) Follow-Up re: Lavigne Music Festival

As a result of information posted on a social media sight, the Mayor sought clarification pertaining to the financing of the 2017 Lavigne Music Festival where the Municipality granted a short-term loan. Councillor Fortier indicated that the update had been provided to staff and that there had been a shortfall. In addition, Councillor Fortier indicated that it has not yet been decided if the festival will proceed in 2018.

- c) The parking or storage of a boat, travel or tent trailer or other non-travel (utility) trailer may be permitted in all required yards in the R1-R4 zones, but no closer than 1.5 metres to any lot line provided the boat or trailer is licensed, in good repair and in serviceable condition.
- d) In the Residential One, Residential Two, Residential Three and Residential Four Zones, such boat, travel trailer, tent trailer or non-travel (utility trailer) if parked in the front yard, must be located in the driveway of the dwelling.
- e) In all other zones, the minimum distance from the boat, travel trailer or tent trailer or non-travel (utility) trailer to the lot line shall be 3m.
- 8. Section 6, Residential Zones, Table 6.3, Residential Zone Requirements:
  - the Minimum Landscaped Open Space in the R1 zone is amended by replacing "n/a" with "30%".
  - b. the Minimum Lot Area on full services in the R2 zone is amended by replacing "225/unit" with "450 (f)".
  - c. the Minimum Lot Area on partial services in the R2 zone is amended by replacing "1000/unit" with "2000 (f)".
  - d. the Minimum Lot Area on private services in the R2 zone is amended by replacing "2000/unit" with "4000 (f)".
  - e. The Minimum Lot Frontage on full services in the R2 zone is amended by replacing "7.5/unit" with "15 (f)".
  - f. The Minimum Lot Frontage on partial services in the R2 zone is amended by replacing "15/unit" with "30 (f)".
  - g. The Minimum Lot Frontage on private services in the R2 zone is amended by replacing "30/unit" with "60 (f)".

#### THE CORPORATION OF THE MUNICIPALITY OF WEST NIPISSING

#### **BY-LAW 2018/02**

#### **BEING A BY-LAW TO LEVY INTERIM TAXES FOR 2018**

WHEREAS Section 317 of the *Municipal Act, S.O. 2001, c. 25,* as amended, provides that the Council of a local municipality, before the adoption of the estimates for the year under Section 317, may pass a bylaw levying amounts on the assessment of the property in the local municipality rateable for local municipal purposes. The amount levied on a property shall not exceed the prescribed percentage or 50 per cent if no percentage is prescribed, of the total amount of taxes for municipal and school purposes levied on the property for the previous year.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF WEST NIPISSING ENACTS AS FOLLOWS:

#### 1. INTERIM LEVY

1.1 That an interim tax levy for the year 2018 be charged on all classes of taxable properties in the Municipality, and that the amount levied on each property shall not exceed 50 per cent of the total previous year's taxes.

#### 2. DUE DATES

- 2.1 The said interim tax levy shall become due and payable in two (2) instalments as follows:
  - 2.1.1 March 23, 2018
  - 2.1.2 April 27, 2018

#### 3. NOTICE OF TAXES

3.1 The Tax Collector shall, no later than twenty-one days prior to the due date of the first instalment, mail or cause to be mailed to the address of the residence, place of business or other designate address of each person taxed, a notice setting out the rates used in calculating the taxes, the respective dates by which they are to be paid to avoid penalty, and the particulars of the penalties imposed by this by-law for default.

#### 4. PAYMENT AND COLLECTION

- 4.1 Immediately after the due dates stated in Section 3 of this by-law, the Tax Collector shall immediately collect at once, by distress or otherwise under the provisions of the statutes, all such instalments or parts thereof that have not been paid on or before the respective dates provided, together with the said percentage penalty charges as they are incurred.
- 4.2 The Tax Collector and the Treasurer are hereby authorized to accept part payment from time to time on account of any taxes, and to give a receipt for such part payment provided that acceptance of any such part payment shall not affect the collection of any percentage penalty charge imposed and collectable under this by-law with respect to non-payment of taxes or of any instalment thereof.

#### 5. METHOD OF PAYMENT

- 5.1 Taxes shall be payable to The Corporation of the Municipality of West Nipissing and are payable:
  - i) at the municipal office in Verner by cash or by cheque or debit card;
  - at the municipal office at 101-225 Holditch Street, Sturgeon Falls, ON, P2B 1T1, by mail, by cash, by cheque or by debit card;
  - iii) at a Financial Institution of your choice; or
  - iv) by Internet or telebanking.

#### 5.2 Pre-Authorized Tax Payment Plan

The Municipality of West Nipissing offers three convenient pre-authorized payment plan

#### 1) Twelve (12) month plan:

- Annual taxes owing are withdrawn over 12 months on the 1st of every month

#### 2) Instalment Plan:

- Annual taxes owing are withdrawn four times a year on the instalment due dates

Note: Plan options 1 and 2 are available to those ratepayers with no outstanding tax arrears

#### 3) Arrears Plan:

- Twelve (12) monthly withdrawals
- Subject to penalty and interest on any balance outstanding on the first of every month.

#### 6. **DEFAULT OF PAYMENT**

- Non-payment of any part of the instalment, due by the dates stated in Section 2.0.0 shall constitute a default.
- In default of payment of any part of the instalment by the day named for payment thereof, the subsequent instalment or instalments shall forthwith become due and payable.

#### 7. **PENALTY AND INTEREST CHARGES**

- 7.1 On all taxes of the interim levy, which are due and payable on March 23, 2018, a penalty of 1.25% shall be added on April 1, 2018 and of the first of every month thereafter that the taxes remain in default until December 31st, 2018.
- 7.2 On all taxes of the interim levy which are due and payable on April 27, 2018, a penalty of 1.25% shall be added on May 1, 2018 and on the first of every month thereafter that the taxes remain in default until December 31st, 2018.
- 7.3 Interest, at the rate of 1.25% per month will be added on all amounts of taxes of the interim levy in default on January 1, 2018 and on the first day of each and every month the default continues.
- 7.4 Penalties and interest added on all tax rates of the interim tax levy in default, shall become due and payable and shall be collected forthwith as if the same had originally been imposed and formed part of such unpaid interim tax levy.

#### **FORCE AND EFFECT**

- 8.1. This by-law shall take force and effect on the day of its final passing.
- 8.2 All by-laws and parts of by-laws inconsistent with this by-law are hereby rescinded.

#### **BY-LAW 2018/03**

#### BEING A BY-LAW TO BORROW MONEY TO MEET CURRENT EXPENDITURES

WHEREAS the Council of the Corporation of the Municipality of West Nipissing deems it necessary to utilize the credit line/operating loan for the current year under the provisions of the *Municipal Act*, 2001, S.O. 2001, as amended;

**AND WHEREAS** Section 407 (1) of the *Municipal Act*, 2001, S.O. 2001, as amended, provides authority for a council by By-law to authorise the Head of Council and the Treasurer to borrow from time to time, until property taxes and other sources of revenues are collected, such sums as the council considers necessary to disburse in a timely manner, the current expenditures of the Corporation for the current year;

**AND WHEREAS** the total amount which may be borrowed from all sources at any one time to meet the current expenditures of the Corporation, except with the approval of the Ontario Municipal Board, is limited by Section 407 (2) of the *Municipal Act*.

NOW THEREFORE the Council of the Corporation of the Municipality of West Nipissing enacts as follows:

- The Mayor and the Treasurer of the Corporation are hereby authorized on behalf of the Corporation, to utilize the credit line, from the National Bank of Canada, hereinafter referred to as "the Bank", a sum or sums not exceeding in the aggregate \$5,000,000.00.
   A portion of the \$5,000,000.00 has been allocated to the following:
- 2. All sums borrowed from the Bank, for any or all the purposes mentioned in the *Municipal Act*, 2001, S.O. 2001, as amended, shall, with interest thereon, be a charge on credit line usage on a daily basis.
- The terms and operating credit may be reviewed periodically by the Bank, including, without limitation, annual reviews.
- 4. The Treasurer is hereby authorized and directed to apply in payment of all sums borrowed under the authority of this By-law, as well as all other sums borrowed in this year and any previous years, from the Bank for any purposes mentioned in the *Municipal Act*, 2001, S.O. 2001, as amended, together with interest thereon, all of the monies collected or received from any other source, which may lawfully be applied for such purpose.
- 5. This By-law shall come into force and take effect on the day it is passed.
- 6. That By-law 2017/04 is hereby repealed.
