Your request to park vehicles along the shoulder of Desaulniers Road in West Nipissing was discussed with the Clerk and as you noted in your request below, the Municipality does not issue 'encroachment permits' for such matters. As share with you the parked vehicles must be stationed in a way as to not block access to private properties on the road. Your message below further indicates that you will be communicating with local property owners as to inform them of the scheduled disruption of road access, please confirm that this has already been done.

Hi Melanie and Janice,

Thank you for taking my calls. Please find this e-mail as an official request to the township of West Nipissing, from our production company, Girl Meets Fella Films regarding parking our unit and technical vehicles on Desaulniers Rd., West Nipissing, ON. I understand that an encroachment permit is not something the town usually grants for these requests. Please kindly advise if we can go ahead and park our unit on this road from Oct. 2nd until Oct.4th, 2019, with the stipulation of making sure all local residents have full access to their property.

Please note, we will provide a notification letter 5 days prior to our arrival to near by residents of our filming so that they are aware of the disruption to their regular routine.

Also, as we will be filming a lot of exterior night scenes, this will require us to work after 10pm. Would it be possible to request a noise by-law exemption from the town for Thursday Oct.3rd into early hours of Friday Oct. 4th, 2019. Could you kindly bring this request to your next council meeting on October 1st.

We can provide the Township of West Nipissing with an insurance policy for having our unit parked on that road. Please advise if you would like me to request a policy to be issued to you.

Please take a moment to read the following information about the filming of GIRL at 2 Desaulniers Rd., West Nipissing on Oct.3rd, 2019. I would like to provide you with as much information as possible about our presence to help you prepare for our arrival and anticipate how our activity might affect your daily routine/business. Girl Meets Fella Productions Inc. will be filming both INDOORS and OUTDOORS tentatively beginning at 3 pm on Oct.3rd and finished by 9am on Oct.4th. Our presence and filming will be CONTINUOUS during this period.

#### DESCRIPTION OF SCENES TO BE FILMED AND SPECIFIC EQUIPMENT/SET DRESSING/PROPS TO BE USED:

The following scenes will be filmed at the location. The Girl peels out in the hatchback as the sheriff pursues her. The Girl sees Charmer and heads inside after him. The girl stabs the charmer and he catches on fire. The girl kills Charmer.

There will be production vehicles, picture vehicles, cube trucks, work trucks, crew cars, trailers, generators, dolly tracks, lighting, used throughout the filming. There will be special effects including controlled pyrotechnics for the burn scene. We will have the West Nipissing Fire Department present at the location. We will also have a medic on set as a precaution.

#### IMPACT ON REGULAR TRAFFIC AND PEDESTRIANS:

There will be some impact on the neighborhood as our unit will be located on Desaulniers Rd.

#### IMPACT ON PARKING:

There will be some impact in the neighbourhood as our unit and crew cars will be parked on Desaulniers Rd. They will arrive on  $Oct.3^{rd}$  at approximately 4am and will depart on  $Oct.4^{th}$  at approximately 9am.
